- 1) End of 1<sup>st</sup> quarter is this Friday, October 16<sup>th</sup>.
- 2) Thanksgiving Break is now the whole week of Thanksgiving



# **Legacy Campaign**

- October receipts likely to NOT meet projection but carryover from first quarter will be used to meet October mortgage payment
- Giving in first quarter 2020-21 was about \$14,000 over LCEF mortgage obligations

## **Church and School Ministry**

- End of first quarter for fiscal year 2020-21
- First quarter 2020-21 general contributions about \$6,000 over same period last year but \$14,000 below projected giving for the first quarter 2020-21
- ➤ Loose plate offerings July September 2020-21 was \$3,159 compared to \$9,427 during the same period last year
- Church and school operating expenses are being well managed and below budget
- ➤ Before & After School Program [Alpha & Omega Club Fees] revenues are below budget due to families not using the program this year, again due to COVID
- > 2020-21 Pre-School Tuition payments are below budget due to change in Pre-School Program after the 2020-2021 Budget was prepared due to COVID.
  - A Monday, Wednesday, Friday [3 day, 3-year-old] Class was canceled effecting revenues by \$53,100.
