Information Security Committee – no update

Parking Lot Improvements – Grant Goris reviewed the breakdown of changes to the plans that were approved by St. Charles County. Project continues to move forward.

Long-Term Planning Update – Tom Ruff commented on Committee activities regarding the following:

- Primary issue over the past five to six weeks involving attempts to communicate with adjacent landowners regarding a conversation to discuss possible church acquisition. No response to date.
- Most immediate need addressing maxed-out facilities, i.e., office space and gathering space such as facilities to hold Bible studies, youth programs, etc.
- Construction to connect the gymnasium and main church buildings.
- On-going investigation into sewer connection needs.
